

CITY OF HOLLADAY

ORDINANCE NO. 09-03

AN ORDINANCE AMENDING THE BUDGET FOR THE CITY OF HOLLADAY FOR THE FISCAL YEAR BEGINNING JULY 1, 2008 AND ENDING JUNE 30, 2009.

WHEREAS, on June 5, 2008, the Holladay City Council adopted by ordinance the budget for the City of Holladay for the fiscal year beginning July 1, 2008 and ending June 30, 2009, in accordance with the requirements of the state statute; and

WHEREAS, the City Administrator has prepared and filed with the City Recorder a proposed amendment to the adopted budget for consideration by the City Council; and

WHEREAS, said proposed amendment reflects changes in the budget from an increase in expenditures and a transfer of funds from Fund Balance; and

WHEREAS, the proposed amendments have been duly noticed and a public hearing held on February 17, 2009; and

WHEREAS, all conditions precedent to the amendment of the budget have been accomplished; and

WHEREAS, the Holladay City Council determines that amending the fiscal year 2008-09 budget is in the best interest of the health, safety, and welfare of the citizens of the City of Holladay, Utah.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Holladay, Utah as follows:

**SECTION 1
BUDGET ADOPTION**

The budget amendment attached hereto as *Exhibit A* and made a part of this Ordinance is hereby adopted and incorporated in the budget of the City of Holladay, Utah for the fiscal year beginning July 1, 2008, and ending June 30, 2009, in accordance with the requirements of state law.

CERTIFICATION**


The City Recorder is hereby directed to have this Ordinance certified by the City Manager as Budget Officer.

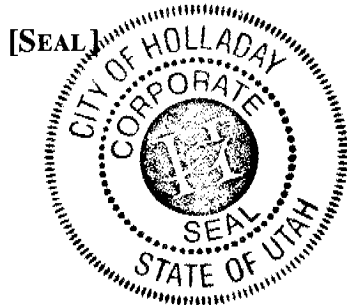
**SECTION 3





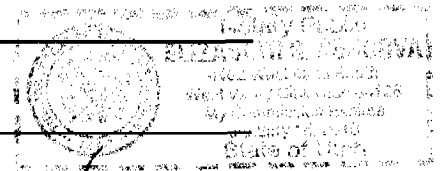
